HSE cracks down hard on dust



HSE's inspectors across Great Britain are targeting construction firms to check that their health standards are up to scratch. HSE dust checks will take place during a month-long inspection initiative, which begins on Monday 4 October 2021.

This year, inspections will focus on respiratory risks and occupational lung disease. As a result, inspectors will be looking at the control measures businesses have in place to protect workers' lungs from construction dust, including silica, asbestos and wood dust.

Fit-out contractor fined after an employee suffered multiple fractures



A fit-out contractor has been fined because an employee suffered multiple fractures after falling fifteen feet from scaffolding.

Manchester Magistrates Court heard on 24 October 2019, an employee of TA Knox Shopfitters Ltd was working from a tower scaffold at the front of the Footasylum Store in the Trafford Centre, Manchester.

When the scaffold moved, it threw him off balance. Subsequently, he fell back against the safety rail of the <u>scaffold</u>. As a result, the scaffold gave way and he fell fifteen feet to the ground. The employee suffered ten fractured ribs, a fractured shoulder, and a collapsed lung.
