Kier trials highways lane closure airbags



Kier is trialling inflatable safety barriers that can be put up in a matter of minutes to help protect road workers.

The new airbags will be used in the Midlands in a bid to reduce the number of motorists who mistakenly drive into work areas, putting the drivers and road workers at risk.

The inflatable barrier is in addition to cones and signs, adding another layer to the traditional traffic management to influence drivers' behaviour and prevent vehicle incursions.

The CPA's TCIG has revised its tower crane guidance in a Technical Information Note (TIN031) managing the design, construction and inspection of tower crane bases, grillages, and ties.

This document is intended to promote the safe design and construction of tower crane bases, grillages and ties through an improved understanding and management of temporary works design, construction, and installation process.

New guidance on the use of face coverings in construction



The Construction Leadership Council (CLC) has announced new guidance on face coverings on construction sites.

The Use of Face Coverings in Construction during Coronavirus (COVID-19) now recommends that face coverings are worn where workers on site are not required to wear Respiratory Protective Equipment (RPE) and their workplace (which may include welfare and changing facilities, office or meetings rooms) meets all of the following criteria:

• an enclosed space; where social distancing isn't always

possible; and

• where they come into contact with others they do not normally meet.

In line with Government guidance on premises providing hospitality, face coverings must be worn in site canteens except when seated at a table to eat or drink.

The Temporary Works Forum (TWf) has revised its guidance on hoardings.

This guidance note from the Temporary Works Forum (TWf) is written to assist all parties involved in construction to understand the key issues, and to give specific assistance to those specifying, managing, designing and installing these structures.

Hoarding design can be complex and needs engineering judgement.

The designer should have a level of competence commensurate with the complexity. All hoarding designs should be independently checked.
