### 'Work Safe, Safe Work' campaign launched

Developed by TrustMark and supported by The Construction Leadership Council, the Work <u>Safe Safe Work campaign</u> has been created to guide and reassure homeowners who are looking to employ tradespeople in and around their homes in a post COVID lockdown world.

The aim is to provide guidance and information to homeowners and tradespeople to restore confidence in the marketplace, raise awareness, and provide guidelines on working safely in customers' homes.

Campaign material includes a short animation and a booklet that can be downloaded or given to the homeowner before a visit to their property, which gives them practical advice about what COVID-safety measures should be discussed and carried out before, during and after work is done in and around their home.

### Workplace Fatality Figures Released for 2019 – 2020

On the 1st July The Health and Safety Executive (HSE) released its annual figures for the number of work-related fatalities in 2019/20, as well as the number of people known to have died from the asbestos-related cancer, mesothelioma, in 2018.

The provisional annual data for work-related fatal accidents revealed that 111 workers were fatally injured at work between April 2019 and March 2020 (a rate of 0.34 deaths per 100,000 workers), the lowest year on record. However in Construction, 40 fatal injuries to workers were recorded, accounting for the largest share. However, over the last five years the number has fluctuated. The annual average for the past five years is 37. The annual average rate over the last five years in construction is around 4 times as high as the all industry rate.
